General

The rate on the confirmation and invoice is binding.

Payments

After receipt of the deposit of 25% of the total amount due, the booking is final.

The remainder (the remaining 75%) will be settled on the day of arrival.

You can pay with us by PIN, credit card (Visa or Mastercard) or by bank transfer. *for payments by credit card, a surcharge of 5% of the total amount applies.

For bookings made 4 weeks or less before arrival, the full booking amount is due.

Cancellation

The parties agree to the following cancellation conditions:

In the event of cancellation of the agreement, the tenant owes cancellation costs that depend on the time of cancellation.

The cancellation conditions are as follows:

Cancellation is free of charge if canceled more than 30 days before arrival.

At 15 to 30 days before arrival we charge 50% of the total price.

If you cancel within 2 weeks before arrival, we will charge the total amount.

Arrival and departure

Use of electricity and water

Normal consumption of water and electricity (air conditioning) is included as well as WiFi, shower towels and linen (change 1x per week).

Normal use of airco is 12 hours per day (24 hours).
